- If a class must be missed due to an emergency, please contact the instructor as soon as possible.
- Subject to the instructor's approval, we accept young handlers if they are able to handle the dog. For handlers under age 16, one parent must accompany the young handler to every class.
- Before coming to class, your dog should be well groomed with his nails clipped.
- Dogs that are ill are not permitted in class—attend without dog and continue working at home.
- Bitches in season must wear protective garments.
- Your dog must be on leash and under control at all times, indoors and out. Dogs must not visit with other dogs coming, leaving, or during class.
- We recommend you not feed your dog before class. Handlers must clean up after their dogs. Clean-up equipment is available indoors. A trash can and bags are supplied outside. Exercise area is in the vicinity of the trash can do not let your dog use any other part of the grounds.
- Due to insurance regulations and for safety, all handlers must wear sneakers or shoes with rubber soles. No high heels, sandals, leather soles, bare feet or foot gear determined by the instructor to be inappropriate will be permitted.
- Suburban Dog Training Club, Inc. reserves the right to excuse any dog or handler who is a danger to the class.

Due to zoning requirements, all dogs 13 weeks and older training at our facility must have a valid **State dog license** and at 16 weeks or older must have a current **rabies vaccine certificate**.

Without proof of rabies and license copy, your application will not be considered complete..

I (we) hereby agree and attest that any dogs that I (we) bring to classes or to participate in other club activities will have a current rabies inoculation in full compliance with all laws applicable to rabies inoculations.

I(we) acknowledge that I(we) have received a copy of the Rules for Suburban Dog Training Club Handlers ("People Commands") governing the conduct of owners and handlers while attending classes or participating in other club activities and agree to comply with said rules and regulations as stated therein and as may be amended and revised from time to time.
